Photographer Consent

To promote Scouting locally, we need to build a library of photographs which can be used on our Website, Social Media, online and printed publicity, signage, banners and all sorts of other methods that we can think of. However, we cannot do this alone, and so rely on our adult volunteers to take photographs of Scouting activities (where the appropriate consents have been granted).

Legally, if you take a photograph or video, you own it (even if you took it on someone else's camera) and as the 'artist', you are the copyright holder for that photograph or video. The purpose of this form is merely for you to licence the CRAI Media Squad SAS Unit, to use any such photographs or videos that you provide them with from now for a period of 5 years, without any royalties. You are still the copyright holder, you are simply allowing us to use and/or adapt any photograph which you provide us with.

Photographs will be considered to have been provided to us if they have been sent in the following ways, and the below licence will therefore cover any such images that you provide by:

- Upload to the CRAI – GSL Support Facebook group
- Upload to the CRAI – Executive Support Facebook group
- Upload to the CRAI – Media Squad Facebook group
- Upload to the CRAI Scouts Facebook page, Twitter account (@CRAIScouts) or Instagram account (@CRAIScouts) or any other Social Media account set up by CRAI Media Squad
- Upload to your own Group or Unit Facebook page or group (where the GSL or DESC has provided the Media Squad with such permissions)
- E-mail or other messenger service (including but not limited to Facebook messenger, Whats App etc) sent either to the CRAI Scouts Facebook page or to any member of the Media Squad.

- We will not include personal details (such as postal addresses, or telephone number) on our social media, website, printed materials or other marketing/promotional materials.
- You have the right to review any photographs stored or used by the Scout Group or CRAI Media Squad, however ask that a photograph of you or your child is submitted with any such request so that we can easily identify photographs featuring you or your child. You may also withdraw your consent at any time.
- Copyright of photographs taken will remain with the artist
